NOTICE OF PROVISIONAL BYLAW AND NOTICE OF COURT OF REVISION

YOU ARE HEREBY NOTIFIED that the Council of The Corporation of the Township of King gave first and second reading to By-law 2020-017 on the 24th day of February, 2020 under Section 46 of the *Drainage Act*, Revised Statutes of Ontario 1990, Chapter D.17 in respect of approval of the Final Engineer's Report dated November 27, 2019 for the **King Drain 15**. This Engineering Report is deemed to be adopted and the by-law shall be known as a provisional by-law. Attached is the provisional by-law exclusive of the Final Engineering Report.

to consider appeals of assessment that have been estimated in the Engineering Report, dated November 27, 2019, prepared by K. Smart Associates Limited for the **King Drain 15**.

Pursuant to Section 52(1) of the *Drainage Act*, an owner of land assessed for the drainage works may appeal to the Court of Revision on any of the following grounds:

- Any land or road has been assessed an amount that is too high or too low;
- Any land or road that should have been assessed has not been assessed; and/or
- Due consideration has not been given to the use being made of the land.

Pursuant to Section 52(2) of the *Drainage Act*, objections or appeals to the assessment **must** be forwarded in writing, to the attention of the undersigned, kmoyle@king.ca, at least ten (10) days prior to the above noted Court of Revision date. Therefore, written appeals **must** be filed with the Clerk of the Township of King on or before **July 11, 2020 at 4:30 p.m.**
